Specific hazards arising from the chemical

: Highly flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. Vapors may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back.

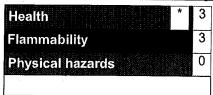
