## Description of necessary first aid measures

Eye contact

Specific hazards arising from the chemical

Large spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. ## Precautions for safe handling

Protective measures

# Appropriate engineering controls

: Use only with adequate ventilation. 
