### SECTION 4 — FIRST AID MEASURES

---

Call a physician and seek medical attention for further treatment, observation, and support after first aid.

Internal: Rinse mouth. Give large quantities of water for dilution. Call a physician or poison control at once.

Nonflammable solid. May form explosive dust clouds in air.

When heated to decomposition, emits toxic fumes of NO<sub>x</sub>, SO<sub>x</sub>, NH<sub>3</sub>, halogen, halogen acids, and possible trace amounts of carbonyl halide.

**Fire Fighting Instructions:** Use triclass, dry chemical fire extinguisher. Firefighters should wear PPE and SCBA with full facepiece operated in positive mode.
