Chlorophenol Red (4430-20-0) 0.4%, Sodium hydroxide (1310-73-2) <0.1%, and Water (7732-18-5) 99%

Lilac basic aqueous solution. Odorless.

SECTION 4 — FIRST AID MEASURES
